James D. Warrener, 41, of The Plains, Ohio, appeared before Judge George P. McCarthy on June 17, 2015, and entered a plea of not guilty to an indictment charging two (2) counts of Aggravated Burglary and two (2) counts of Felonious Assault. Judge George P. McCarthy set Warrener's bond at \$100,000.00 with no 10% allowed and scheduled a jury trial for July 7, 2015. Prosecutor Blackburn reports that "on or about May 11, 2015, Warrener is accused of stabbing another individual in the back, unprovoked and chasing them with a two by four." This case was investigated by the Athens County Sheriff's Office.

Noel Anthony, 46, of Nelsonville, Ohio, appeared before Judge George P. McCarthy on June 17, 2015, and entered a plea of not guilty to an indictment charging two (2) counts of Robbery and two (2) counts of Aggravated Burglary. Judge George P. McCarthy set Warrener's bond at \$100,000.00 with no 10% allowed and scheduled a jury trial for July 7, 2015. Prosecutor Blackburn reports that "on or about May 9, 2015, Anthony is accused of entering the Valero gas station, pointing a gun at the attendant and demanding money from the attendant." This case was investigated by the Athens County Sheriff's Office.

Anna B. Spears, 33, of The Plains, Ohio, appeared before Judge George P. McCarthy on June 17, 2015, and entered a plea of not guilty to an indictment charging two (2) counts of Robbery. Judge George P. McCarthy set Spears' bond at \$50,000, with no 10% allowed and scheduled a jury trial for August 25, 2015. Prosecutor Blackburn reports that "on or about June 5, 2015, Spears is accused of assisting two (2) other individuals in the robbery of the Certified gas station." This case was investigated by the Athens County Prosecutor's Office and the Glouster Police Department.

Guy Wolfenbarger, Jr., 41, of Columbus, Ohio, appeared before Judge Patrick J. Lang on June 18, 2015, and entered a plea of not guilty to an indictment charging two (2) counts of Robbery and one (1) count of Possessing Criminal Tools. Judge Patrick J. Lang set Wolfenbarger's bond at \$100,000.00 with no 10% allowed and scheduled a jury trial for August 25, 2015. Prosecutor

Blackburn reports that “on or about June 5, 2015, Wolfenbarger, with the assistance of two (2) other individuals, is accused of robbing the Certified gas station in Glouster, Ohio.” This case was investigated by the Athens County Prosecutor's Office and the Glouster Police Department.
